Third working meeting. Involving the participation of the expert teams of the partner municipalities, the NTEF team and the team of the Bulgarian consultants. Remote inclusion in the meeting on the part of the experts from the Western Norway Research Institute.

- Finalization of the analytical reports on the basis of the steps envisaged in the methodology
- Presentation of a project fiche justification of the manner, in which the measure shall lead to a climate change adaptation and more particularly – to the threat and the risk, which are characteristic for the concrete location, the activities that should be implemented
- Work in a team by municipalities with discussions within the big group. Professional help and assistance by the consultation team, in this number specialists in greening and waters.

Green corridor between two parks

Major threat: The heating in urban environment – heat island effect.

Objective of the measure: To reduce the negative effect of this threat on people, infrastructure and urban environment through specific adaptation measures.

Solution: Creation of blue-green infrastructure through shading and cooling of a public space.

Object of the intervention: A street with 280 m length, which is a natural link between two big parks, representing unimproved open space. It is a part of a pedestrian route, connecting the Central city part with several neighborhoods.

The place has all characteristics of the threat: sealed area, open space without vegetation, high temperatures during the summer period.

As of the present moment a preliminary design is prepared, after which contract for engineering will be awarded.

Green corridor between two parks

The following activities are envisaged:

- Unsealing of soil removal of paving tiles to increase the green area;
- Shading through planting of non-invasive vegetation, which is resilient to climate changes in urban environment appropriate tree species and climbing plants, pergolas;
- Grassing of the determined areas, including planting of ornamental plants;
- Separation of corners for relaxation, covered with climbing vegetation;
- Building of irrigation system;
- Installment of electronic board, recording the air temperature and the time;
- Installment of fountains for use by people and animals;
- Construction of water element;
- Replacement of concrete pavement with a garden path.
